

#### Q1 Has your company experienced work stoppage related to COVID-19?





#### Q2 How has your company backlog been affected by COVID-19?







#### Q4 Are you working on any emergency relief projects?





## Q5 If your state has issued 'essential service' guidance, has construction and/or demolition and remediation work been included in the 'essential service' directive?





### Q6 Has your company furloughed, laid-off or instated a hiring freeze? (check all that apply)





#### Q7 How has your operating budget been affected by COVID-19?




